WISCONSIN PROFESSIONAL BASEBALL PARK DISTRICT FINANCE COMMITTEE MEETING MINUTES July 15, 2024

1) Call to Order

Chairperson Zapfel called the meeting to order at 11:34 am and asked for a roll call of Committee members. All members except Kevin Newell were present. Chairperson Zapfel stated for the record that a quorum of Committee members was present to conduct business. (At 11:45 am, Kevin Newell joined the meeting by phone.)
